

Harvard Referencing Study Guide

The Harvard Referencing System is commonly used for referencing sources. However check with your lecturer or course handouts for any specific requirements and follow their preferred referencing method.

Why reference your assignments?

Referencing your assignments avoids plagiarism by acknowledging the original author or source of the information. It enables your reader to evaluate the worth of the sources by reading your list and to follow-up on those resources for themselves.

What do you need to reference?

If you use someone else's ideas in your assignment you must include a reference to that idea in the body of the assignment and also at the end of the assignment in a reference list or bibliography. If you use exact words (quotations) from someone else's work, re-word (paraphrase), summarise, or use specific information (diagrams, statistics, tables or images) from someone else's work, you need to reference that source.

In-text Reference

The brief **in-text reference** or **citation** is included in the text of your assignment. Generally, you need to include the author's surname (or title if author is unknown), year of publication and the page number (if relevant). Examples of in-text references are provided on the following page.

End-text Reference

At the end of your assignment or essay, you need to include full details of the sources you used in a Reference List or Bibliography. It is a good idea to collect all the publication details (title, author, place of publication, date, etc) for every source **as you go** – it may save you time later!

- Start your reference list or bibliography on a new page
- Use the heading References or Bibliography
- Use a new line for each resource
- Arrange your Bibliography or Reference List in alphabetical order by the Author's last name or if there is no known author, the first word of the Title. Do not use numbers or bullets
- If you have two or more works from the same Author then alphabetise them first according to the Author's last name & then in chronological order by publication date

Reference List or Bibliography?

A **Reference List** is an alphabetical list of all the books, websites, magazine articles, etc you consulted AND you used directly in your assignment.

A **Bibliography** is an alphabetical list of all the resources you consulted – books, websites, magazine articles, etc WHETHER OR NOT you used them directly in your assignment.
